Debbie Bliss appears to have entered into a licensing agreement with Designer Yarns whereby Designer Yarns owns and controls the Debbie Bliss brand name and Debbie is an independent contractor for books of design patterns. Debbie has ***no ownership*** in Designer Yarns; she is neither a shareholder nor a director of Designer Yarns. Designer Yarns is clearly not Debbie's company.

Despite the September, 2006 letter – distributed to US yarn shops by KFI – where Debbie acknowledges a responsibility to maintain standards and ensure quality, Debbie appears to have no day-to-day role in Designer Yarns' business: the selection, specification, manufacture and pricing of the Debbie Bliss line of yarns and the selection of the distributors for these branded products.
